

## Machinery Mover Information

All parties using any form of mechanized or powered material handling equipment, including forklifts, to remove items from this facility must FIRST submit a valid Certificate of Insurance with General Liability and Worker's Compensation coverages, each with limits no less than \$1,000,000.

Machinery movers will not be able to perform any such work until we receive a Certificate of Insurance.

All Certificates of Insurance must list the following companies and addresses as additionally insured:

All floor bolts and/or anchoring fasteners are to be cut flush to the floor and the area left broom clean.

Any hydraulic and oil fluid and leaks are the responsibility of the rigger to remove and clean up.

Any miscellaneous conduit, wires and studs in cement must be removed.

Bridge cranes and hoists may be used only by riggers with crane insurance on their certificate and only with written permission of crane owner.

Liabile for damages - any structural damage to walls, overhead doors, gates etc. will be rigger's responsibility. Field supervisors are instructed to report damage to the Heath Industrial home office and plant personnel immediately. Riggers will not be permitted to leave with equipment until repairs are made.
